All Board meetings and workshops are open to the public.

I want to thank all the Matteson business owners and/or staff and many residents who participated in the "Business after Hours" event held at South Oak Dodge last month. We had an overwhelmingly positive response to our call to organize businesses located in and around Matteson under this newly created organization. We believe that in these economic times particularly, it is very important for us to mobilize Matteson's vibrant and successful business community to help current businesses grow and to attract new businesses that will add value to our Village. Please look for future events sponsored by the Matteson Business Association. We are moving forward with our mission to ensure the continued success of Matteson as a business Mecca of the South Suburbs. We have several economic development projects that are in the early phase that we hopefully will be making announcements on in the near future. Perhaps the most mispronounced name of all of Chicago's suburbs. It's not "MATT-sun." It has three syllables, matt . e sun and sounds a lot like Madison, Wis. The south suburbs is named for Joel Aldrich Matteson, the 10th Governor of Illinois (1853 to 1857). The businessman was in office when the area was settled.

## Economic Development Update

\* The Village of Matteson hired an Economic Development Consultant to assist the Economic Development Department with the future development, attraction and retention of retail businesses and projects in the community. Larry Kilduff of The Kilduff Company has decades of successful experience in developing commercial real estate. With his experience comes an extensive list of contacts with national retailers as well as the understanding of capital market, which is critical in structuring projects and negotiating with financial entities. The Village of Matteson is excited to be working with Mr. Larry Kilduff and is looking forward to the experience he will bring to enhance the development of the community.

\*A Community and Economic Development Task Force has been implemented to create a redevelopment plan for the Village's retail corridors. The plan will illustrate enhanced landscaping features, façade improvements, and reconfiguration of shopping plazas for better access. The village retail corridors has been broken down into various sections and phases to achieve a complete plan. The first section will entail the gateway into the community which begins off the southbound exit of I-57 to the southwest corner of Rt. 30 & Cicero Ave. and just south to Southwick Drive.

\* A Tax Increment Financing (TIF) District has been adopted for the Auto Mall to assist with the revitalization and redevelopment of the area. The auto industry is among one of the hardest hit financially in the economy. Over the last couple of years, several car dealerships have closed or consolidated which left buildings vacant and not maintained; ultimately, creating blight within the area. The TIF will assist in attracting future development.

\* Construction has begun on Phase 1 of the new Matteson Community Center which will consist of the construction of the outdoor amenities including two baseball fields, a soccer field, a football field and track as well as basketball and tennis courts. The new community center will be located south of the Colin Powell Middle School.

\* Over two dozen businesses opened their doors in Matteson in the last year creating more than 50 jobs in the community.

## Reminder from the IRS—Taxpayers take Advantage of Recovery Act Benefits

### First Time Homebuyer Credit:

Taxpayers who didn't own a principal residence during the past three years and purchased a home this year before December 1st, can receive a credit of up to \$8,000 on either an original or amended 2008 tax return or a 2009 return.

### New Vehicle Purchase Incentive:

Qualifying taxpayers can deduct the state and local sales and excise taxes paid on the purchase of new cars, light trucks, motor homes and motorcycles.

### Energy Efficient Home Improvements:

The credit for non-business energy property has increased for homeowners who make qualified energy-efficient improvements to existing homes.

### Tax credit for First Four Years of College:

The American Opportunity Credit is designed to help students pay part of the cost of the first four years of college. Tuition, related fees, books and other required

course materials generally qualify. Many of those eligible will qualify for the maximum annual credit of \$2,500 per student.

### Certain Computer Technology Purchases Allowed:

Computer technology is on the list of college expenses that can be paid for by a qualified tuition program (QTP) or the 529 plan.

## THE U.S. CENSUS BUREAU IS ISSUING A CALL TO ACTION FOR EVERY CITIZEN OF OUR NATION: "BE COUNTED IN 2010."

Do you know the importance of Census Data? Every year the federal government allocates more than \$400 billion to states and communities based in part, on census data.

This data is used to determine locations for retail stores, schools, hospitals, new housing developments and other community facilities.

As well, it determines boundaries for state and local legislative and congressional districts.

Easy, Important and Safe is what describes the 2010 Census Questionnaire:

Ten questions and approximately 10 minutes to complete, is the length of time households are asked to provide key demographic information, including whether a housing unit is rented or owned; the address of the residence; and the names, genders, ages and races of others living in the household.

By law, the Census Bureau cannot share an individual's responses with anyone, including other federal agencies and law enforcement entities.

### COMPLETE YOUR QUESTIONNAIRE: WE CAN'T MOVE FORWARD UNTIL YOU SEND IT BACK!

**WHAT:** The census is a count of everyone residing in the United States.

**WHO:** All U. S. Census residents must be counted—people of all races and ethnic groups, both citizens and not citizens.

**WHEN:** Census Day is April 1, 2010. Questionnaire responses should represent the household as it exists on this day. More detailed socioeconomic information will be collected annually from a small percentage of the population through the **AMERICAN COMMUNITY SURVEY.**

**WHY:** The U.S. Constitution requires a national census once every 10 years. The census will show state population counts and determine representation in the U.S. House of Representatives.

**HOW:** Census questionnaires will be delivered or mailed to households via U.S. mail in March 2010; many households will receive a replacement questionnaire in early April. Census workers also will visit households that do not return questionnaires.

## LINCOLN HIGHWAY

The concept of Lincoln Highway stemmed from Carl Fisher, the man responsible for building the Indianapolis Motor Speedway and Miami Beach. Fisher, along with industrialists Frank Seiberling and Henry Joy, imagined a hard-surfaced road that would stretch 3,400 miles from Time Square in New York to San Francisco, California (over the shortest distance possible).

In 1912, Fisher actively promoted his dream of a transcontinental highway (mainly amongst his automobile industry friends). The project, which would cost about \$10 million, would have to be completed by May 1, 1915 in sufficient time for the Panama-Pacific International Exposition in San Francisco. Within a month, Fisher's automobile industry friends had guaranteed \$1 million.

By July 1913, a name was chosen for the road. Fisher and Associates decided to name the road after Fisher's hero, Abraham Lincoln. On July 1, 1913 the Lincoln Highway Association (LHA) was established by a group of automobile supporters and industry officials. The LHA was created to promote the using of private and corporate donations for the project.

By the mid-1920's, the Nation was intertwined with approximately 250 named trails. In 1925, the Joint Board on Interstate Highways was established to create the U.S. numbered system of highways. E.W. James, Secretary of the Joint Board, realized the dominance of the Lincoln Highway and how the new system would be the end of the Lincoln Highway. The numbering system divided the Lincoln Highway into several parts: U.S. 30 between Philadelphia and Granger, Wyoming; U.S. 1 which is east of Philadelphia; U.S. 40 which is west of Salt Lake City.

In 1928, the LHA ended promoting the Lincoln Highway but not without one last announcement. The Lincoln Highway was officially marked and dedicated to the memory of Abraham Lincoln on September 1, 1928. On that day 3,000 concrete markers were placed among sites along the route. The signs bared the Lincoln Highway coat of arms, a bronze medallion (which says "This Highway Dedicated to Abraham Lincoln) and a directional arrow.

In its prime, the Lincoln Highway was the Nation's premier highway. The route is historic: it was part of the U.S. Army's first transcontinental motor convoy; it was the inspiration to the Dwight D. Eisenhower System of Interstate and Defense Highways; and it was even honored by having a 1940's radio show named after it. The success of the Lincoln Highway was and continues to be a catalyst for highway advancement around the country.

## **Trash Storage and Pick-Up**

Improperly stored garbage is a nuisance and creates an eyesore as well as attracts unwanted vermin in residential areas.

All garbage shall be drained, wrapped and stored in durable, rust-resistant, non-absorbent, water-tight containers not to exceed 30 gallon capacity and which have close fitting covers. Plastic garbage bags are permitted for use outside as containers for garbage collection day only must be closed securely and are not to be used for outside storage of garbage at any time.

It shall be the duty of any person having household garbage, rubbish or yard waste to place sealed, durable containers not to exceed 30 gallons in capacity or tightly closed plastic garbage bags, and yard waste bags or containers, on the curb in front of the premises, or in the alley adjacent to the premises, if garbage collection is made in the alley, not before 8:00 p.m. of the day prior to garbage collection being made and also to remove the containers prior to 8:00 p.m. the day collection has been made.

## *FYI—Board Meetings:*
