Napoleon Haney — Matteson's New Village Administrator



With a belief in serving the community through public administration, Napoleon Haney, M.P.A. has been hired as the new Matteson Village Administrator, effective June 1, 2009. Leaving his post after serving three years as Special Assistant to the City Manager in Reno, Nevada, Mr. Haney assisted in managing the City of Reno, a community of 220,000 and now manages Matteson with a population around 17,000. Although the population numbers are quite different, Haney says, "The issues and expectations are still the same."

Recruited to Reno and back for his position here with Matteson, he is no stranger to the area. Mr. Haney served as Assistant to the Village Manager/Director of Personnel for the Village of Park Forest after his Village Planning/Economic Development position in Robbins. He credits his start in local government to Mayor Irene H. Brodie of Robbins, IL. "She gave me my first municipal job," says Haney.

A results oriented person, Mr. Haney expects high performance from his team and judging from his background and résumé, none of the staff can afford to produce any less.

His highlights and accomplishments include success at contract and collective bargaining/negotiations on every level including telecommunications carrier contracts, health and dental insurance and development agreements. Haney has initiated land development projects from land acquisitions to construction/completion oversight; he has been a budget manager, a mediator,

project manager, risk management director, and a business and developer recruiter and grant writer/administrator. He has covered every gamut of Public Administration from finance to public works and has been extremely successful. This United States Marine, Veteran of Desert Shield and Desert Storm is also the recipient of good conduct medals which explains his disciplined approach to local government.

Chief Edwin D. "Nick" Wilkens Retires after 41 Years



One of the original six full time Firefighters in 1977, Chief Edwin D. "Nick" Wilkens started his career with the Matteson Fire Department as a volunteer on July 1, 1968. The following May he was appointed to a full time position with the Department of Public Works. As a Volunteer he worked through the positions as Firefighter, Engineer, Lieutenant and finally Captain.

Chief Wilkens family is no stranger to the Fire Service. His wife's grandfather was a charter member of the Matteson Volunteer Fire Department in 1894. His father-in-law was a member for many years, as well as his brother-in-law, nephew and son. His brother-in-law recently retired as a full-timer from the Matteson Fire Department. And his son and two nephews work full-time for other area Departments. The Chief's mother-in-law was a charter member of the former Ladies Auxiliary and wife Kathy followed in that organization.

When Chief Wilkens started his career in 1968 the Department responded to less than 200 calls per year. At present the Department responds to just under 5,000 out of two stations with a minimum staffing of eight Firefighter/Paramedics on duty. During the all Volunteer days there were 35 Volunteers and no full time personnel. Today the Department has 35 sworn personnel, five Paid-on-Call, a full time Fire Prevention Bureau with three people and an administrative assistant.

During Chief Wilkens decorated career he moved through the ranks as a Certified Paramedic, Lieutenant, Shift Commander and Deputy Fire Chief in 1986. He was appointed Fire Chief in 2004. He received an Associates Degree from Prairie State College, Bachelor of Science from Southern Illinois University-Carbondale in Fire Administration and a Master of Science in Public Safety Administration from Lewis University. The Chief is also a Certified Firefighter III, Fire Officer III, Fire Service

Instructor IV and received Chief Fire Officer Designation from the International Association of Fire Chiefs where he joins less than 500 other Chief Officers world wide.

After retirement Chief Wilkens plans on keeping a little busy in the Fire Service, but says there are many golf balls he hasn't lost yet and many more worms to drown while fishing. He will continue with gardening and the most fun trying to keep up with his four year old grandson and two year old granddaughter. He and his wife Kathy reside in the older section of Matteson, but have plans to build in the St. Louis area in the future.

When asked to sum up his career, Chief Wilkens says, "I want to thank Presidents Ashmore and Stricker for the opportunity to serve the residents of Matteson as their Fire Chief, and a thank you to the highly trained and dedicated men and women of the Department. I've had a great career with the Village and will long remember the friends and many coworkers I have been known for the past 41 years. It will be bittersweet to leave this organization, but I know there will be qualified and dedicated people to follow and keep the Fire Department one of the finest in the area."

**ComEd Invests
Nearly \$1.8 Million in
Suburban Electric
Service**



In an effort to maintain reliable electric service to customers in and around Matteson, Monee and Chicago Heights, ComEd has invested nearly \$1.8 million to enhance a local substation, which will prove to be especially beneficial during the summer peak period.

Completed in May, the work features installation of more than 5 miles of new and upgraded distribution line. This includes the town of Matteson from Richton Road to Ridgeland Avenue along ComEd Right of Way south of Elgin-Joliet railroad; in Monee Township along Monee-Manhattan Road from Ridgeland to Harlem avenues; and in Chicago Heights along State Street for a half mile south from Joe Orr Road.

The lines directly serve about 2,700 business and residential customers in those communities, but the work provides benefits to most area residents by supplying additional reliable pathways when electrical load must be shifted to quickly restore customers during storms and when other unplanned outages occur.

"Despite economic pressures from the global recession, ComEd is committed to maintaining system reliability through targeted local investments like these," said Anne Pramaggiore, ComEd's president and chief operating officer. "We are pursuing every way to become more cost-effective and ensure reasonable rates for our customers, and our primary customer commitment remains unchanged - to keep the lights on."

Since 2001, ComEd has invested more than \$5 billion to expand and upgrade its transmission and distribution systems. This has resulted in a 39 percent reduction in the frequency of customer interruptions since 1998, and a shortening of outage duration by 34 percent in the same period.

In addition to these infrastructure investments, the company performs regular maintenance work to ensure reliable electricity delivery, such as vegetation maintenance to free electrical lines from interference, system engineering to achieve optimal equipment operations, and regular visual inspections of above ground electrical lines.
